ELMER MENDOZA, CORPORATE SECRETARY ON THE FREE INSTALLATION OF A STAND-ALONE TRAFFIC MANAGEMENT SYSTEM IN THE INTERSECTION OF SUSANA HEIGHTS AVENUE AND NATIONAL ROAD, BARANGAY TUNASAN, MUNTINLUPA CITY

WHEREAS, Section 16 of Republic Act 7160 or the Local Government Code of 1991, provides that, *“Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*;

WHEREAS, Section 22(c), Supra, further provide that, *“unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”*;

WHEREAS, an unsolicited proposal from PMR88 Development Corporation, a Filipino business with working consortium of internationally proven technology providers of advanced and smart traffic systems and components, to install a stand alone traffic management system in the intersection of Susana Heights and National Road, Barangay Tunasan was offered to the City Government of Muntinlupa;

WHEREAS, the stand alone traffic signaling system will be installed free of charge which installation shall commence September 11, 2023 until October 2, 2023 and trial/experimentation and data collection shall be from October 3, 2023 until November 3, 2023;

WHEREAS, during the trial experimental period, data being generated may be assessed by the City and its stakeholders to confirm efficiency and efficacy of the proposed system and in determining the system's suitability and connectivity to the present smart city traffic concept and traffic command center;

WHEREAS, the CGM pursues innovation with that of being offered by the PMR88 as it gears towards its vision to being a Smart City and the fruition of its 7K Agenda;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon**, to enter and sign the **Memorandum Of Agreement (MOA)** with **PMR88 Development Corporation**, represented by **Atty. Elmer Mendoza**, Corporate Secretary on the **free installation of a stand-alone Traffic Management System** in the intersection of **Susana Heights Avenue and National Road, Barangay Tunasan, Muntinlupa City**.

RESOLVED FURTHER that the MOA should be revised to: explicitly state the advantages and benefits that the city will derive from the trial/experimentation; a favorable endorsements must be issued by the offices alluded in the MOA for specific performance namely, the Muntinlupa Traffic Management Bureau, Disaster Risk Reduction and Management Office and the City Planning and Development Office.

RESOLVED FINALLY, that the CGM shall be absolved from any liability arising from damage, loss or injury to the system/equipment.
