**WHEREAS**, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **"every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;**

**WHEREAS**, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-IRR), provides that, **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."**

**WHEREAS**, on May 2023, the City Council passed Resolution No. 2022-090 granting unto the City Mayor the authority to enter into a Memorandum of Understanding (MOU) with Japan International Cooperation Agency (JICA) and Fujifilm Philippines, Incorporated (FUJIFILM) for funding and documentation of the use of Technology for Tuberculosis which effectivity already lapsed;

**WHEREAS**, Fujifilm, without the support of JICA, offers the use of an Artificial Intelligence-Powered Computer-based Detection (AI-CAD) and flat panel detector for TB screening in Putatan Health Center for the period of two (2) years to commence on June 30, 2023 up to June 30, 2025.

**WHEREAS**, without the JICA's financial support, the funding for the maintenance and other costs for the operation of the Fujifilm's equipment shall now be for the account of the City Government of Muntinlupa;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, authorizing the Hon. City Mayor Rozzano Rufino B. Biazon, to enter and sign the Memorandum Of Understanding (MOU) on the use of Fujifilm's Artificial Intelligence-Powered Computer-Based Detection (AI-CAD) and Flat Panel Detector for TB Screening in Putatan Health Center, Barangay Putatan, Muntinlupa City.
