WHEREAS, the State shall promote a just and dynamic social order thereby uplifting its citizens and marginalized sectors from poverty through policies that provide adequate social services, promote full employment, a rising standard, and an improved quality of life for all. The State further recognizes the need to foster social justice as provided for in Article XIII of the 1987 Constitution;

WHEREAS, Article 86 (b)(1)(vi) and (viii) of the Local Government Code of 1991, provides that, "**the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances**";

WHEREAS, Republic Act 11310 or the Pantawid Pamilyang Pilipino Program (4Ps) Act of 2019 is the national poverty reduction strategy and a human capital investment program that provides conditional cash transfer to poor households for a maximum period of seven (7) years, to improve health, nutrition and education aspect of their lives;

WHEREAS, to enable the beneficiaries to successfully exit from the 4Ps Program, the local government unit is tasked to ensure that the necessary infrastructure such as schools and health centers are in place and that health, nutrition and education services are provided or made available. The collaborative efforts between the LGUs and the DSWD likewise extend to capability building and related capacity development activities of the beneficiaries, partners and 4Ps personnel;

WHEREAS, the **Specific Implementation Agreement (SIA)** setforth the obligations of parties, which compliance is imperative in order that the supply side requirements necessary in the attainment of the qualified household-beneficiaries to program conditions and provisions of complementary support services in preparation for the households' eventual exit from the program;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon**, to enter and sign the Specific Implementation Agreement (SIA) with the Department of Social Welfare and Development - National Capital Region (DSWD-NCR) for the Pantawid Pamilyang Pilipino Program (4ps) beneficiaries in the City of Muntinlupa.

RESOLVED FURTHER, that the Social Services Department of the City of Muntinlupa shall exert effort to address the grievances and protests arising from the implementation of the 4Ps in the City by including a system/policy/measure for its settlement in the SIL.
