WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **"every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;**

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-RR), provides that, **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";**

WHEREAS, by virtue of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the delivery of health services and facilities were devolved to the Local Government Units, hence, LGUs are the primary holder of medical records of the constituents who opt to avail of the public health services;

WHEREAS, the Department of Health, aside from being the principal health agency in the Philippines responsible for ensuring access to basic public health services to all Filipinos, likewise is mandated to be the over-all technical authority in health in three major roles of leadership and regulator in health, enabler and capacity builder, and administrator of special health services;

WHEREAS, streamlining an existing manual reporting system that was burdensome and time consuming, the Department of Health (DOH) has utilized the capabilities of internet and the use of information and communication technologies in health to achieve accuracy, reliability or validity of data, and the timeliness of submission which are basis for evidenced-based decision-making;

WHEREAS, DOH proposes the adoption of the **iClinicSys** which is an electronic medical record and health information system that supports the function of a primary health care facilities including Rural Health Units (RHUs), Health Centers (HCs) and Barangay Health Station (BHS). It aims to automate service delivery processes to efficient manage the patient demographics, medical histories, diagnoses, treatments, medications, laboratory requests and results and generate the required data for the health provider's use and submissions to the DOH and Philhealth;

WHEREAS, other than complying with Memoranda and pertinent laws on submission of health reports to national agencies, the City Government of Muntinlupa supports such technology to ensure that the targets for disease elimination, prevention and control is in place as it gears itself to becoming a "Smart City";

WHEREAS, The City Legal Office finds nothing legally objectionable to the Execution of the MOA, subject to the compliance with the provision of the DPA particularly in processing of personal information of the data subjects;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon**, to enter and sign the Memorandum of Agreement (MOA) with **Department of Health Center for Health Development, National Capital Region (DOH CHD-NCR)** represented by **Aleli Anne Grace P. Sudiacal, MD, MPH, CESE, Director IV**, on the implementation of the **Integrated Clinic Information System (ClinicSys)**
