A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH RGDG CONSTRUCTION, FOR THE PROJECT MILK BANK FACILITY AT OSPITAL NG MUNTINLUPA LOCATED FILINVEST CORPORATE CITY, BARANGAY ALABANG, MUNTILUPA CITY IN THE AMOUNT OF (PHP2,854,885.93) WHICH AMOUNT SHALL BE TAKEN FROM THE 2023 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF)

WHEREAS, Section 2 of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, provides that, "It is the declared policy of the State to promote the ideals of good governance in all its branches, departments, agencies, subdivisions, and instrumentalities, including government-owned and/or -controlled corporations, and local government units";

WHEREAS, Section 3 of the 2016 Rules and Regulations Implementing RA 9184 states that, "The procurement of the Government of the Philippines shall be governed by the principle of transparency in the procurement process and in the implementation of procurement contracts through wide dissemination of bid opportunities and participation of pertinent non-government organizations," among others;

WHEREAS, Section 7, supra, provides, "All procurement shall be within the approved budget of the Procuring Entity and should be meticulously and judiciously planned by the Procuring Entity. Consistent with government fiscal discipline measures, only those considered crucial to the efficient discharge of governmental functions shall be included in the Annual Procurement Plan (APP)";

WHEREAS, Article 86 (b) (1) (vi) of the Implementing Rules and Regulations (IRR) of Local Government Code of 1991, provides that, ***“The City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”;***

WHEREAS, the City Government of Muntinlupa, in its approved APP, listed the project/s: ***Milk Bank Facility for Ospital Ng Muntinlupa located Filinvest Corporate City, Barangay Alabang, Muntinlupa City;***

WHEREAS, the duly constituted Bids and Awards Committee (BAC) of Muntinlupa, acting on its mandate, advertised the invitation to apply for eligibility and to bid for the project: ***Milk Bank Facility for Ospital Ng Muntinlupa located Filinvest Corporate City, Barangay Alabang, Muntinlupa City.*** To comply with the provisions of Procurement Act and its IRR, and R.A. 8792, otherwise known as the “Electronic Commerce Act, the same project was likewise posted continuously for seven (7) days at the *Philippine Government Electronic Procurement System (PhilGEPS)*, City’s website and conspicuous places within the premises of the City Government of Muntinlupa;

WHEREAS, in response to the said advertisement/s and publication/s, two bidders submitted its/ their letter/s of intent and application/s for eligibility:

WHEREAS, on **August 8, 2023**, **RGDG Construction**, submitted its bid documents. In the Preliminary Examination of Bid conducted at the City Administrator’s Conference Room, 2nd Floor City Hall Main Building, it was determined that the required bid documents are present and may be considered for opening and evaluation of their financial component;

WHEREAS, after careful examination, validation and verification of all the eligibility, technology and financial requirements, **RGDG Construction**, bid was adjudged to be responsive to the **Approved Budget for the Contract (ABC)** amounting to **Two Million Eight Sixty-Six Thousand Eight Hundred Eighty-Five Pesos and 84/100 (Php2,866,885.84)**. Thereafter, the project was awarded to **RGDG Construction**, as the Highest Rated Responsive bidder for the project ***Milk Bank Facility for Ospital Ng Muntinlupa*** located at ***Filinvest Corporate City, Barangay Alabang, Muntinlupa City;***

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod, to authorize the City Mayor Hon. **Rozzano Rufino B. Biazon**, in behalf of the City Government of Muntinlupa to enter into a **Construction Agreement** with **RGDG Construction**, for the project ***Milk Bank Facility for Ospital Ng Muntinlupa located Filinvest Corporate City, Barangay Alabang, Muntinlupa City*** in the amount of ***Two Million Eight Hundred Forty-Four Thousand Eight Hundred Eighty-five Pesos and 93/100 (Php2,854,885.93)*** which amount shall be taken from the 2023 Executive Budget Under 20% Community Development Fund (CDF).

RESOLVED FURTHER, that **Comelec Resolution No. 10944** or the *Rules and Regulations on the Prohibition against the Release, Disbursement, or Expenditures of Public Funds and Construction of Public Works, Delivery of Materials for Public Works, and Issuance of Treasury Warrants and Similar devices under Section 261 (V) and (W) of the Omnibus Election Code in Connection with the October 30, 2023 Barangay and Sangguniang Kabataan Elections*, sets 20 October to 29 October, 2023 as the prohibited period for the **Milk Bank Facility for Ospital Ng Muntinlupa** located *Filinvest Corporate City, Barangay Alabang, Muntinlupa City* **IS NOT** within the purview of the election ban;

RESOLVED FINALLY, that the City Government of Muntinlupa, sought exemption from the provision of Section 261 (V) of the Omnibus Election Code in Connection with the October 30, 2023 Barangay and Sangguniang Kabataan Elections, which approval is embodied in the **COMELEC Law Department's Notice No. 23-06065** dated **September 13, 2023**, which shall be annexed as integral part of this Resolution;
