WHEREAS, Article XIII, Section 11, of the 1987 Constitution provides that, "The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable costs, prioritizing the needs of the underprivileged sick, elderly, disabled, women and children.";

WHEREAS, Section 455 (b)(1)9(vi) of the Local Government Code provides that, "the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 16 of R.A 7160, the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod";

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall:

(1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing the Local Government Code of 1991 provides that, "Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.";

WHEREAS, Section 35 of LGC of 1991, provides that, "Local government units may enter into joint ventures and such other cooperative arrangements with people's and nongovernmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.";

WHEREAS, Fresh 'N Famous Foods Inc., - Greenwich Philippines, a corporation duly recognized and existing under the laws of the Republic of the Philippines, with office address at 10th Floor Jollibee Plaza Building, F. Ortigas Jr. Avenue, Ortigas Center, Pasig City, represented herein by Ma. Alfonso Romero Roderos;

WHEREAS, pursuant thereto, the CGM enters into a Memorandum of Agreement with Fresh 'N Famous Foods Inc., - Greenwich Philippines, represented by Ma. Alfonso Romero Roderos a local company on the temporary employment of qualified Senior Citizens (SCs) and Persons with Disability (PWDs);

WHEREAS, the MOA was submitted for review and the City Legal Office, interposed no objection as long as the relevant laws, guidelines and circulars on the matter are complied with;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the Honorable City Mayor Rozzano Rufino B.
