WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”**;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”**;

WHEREAS, by virtue of Republic Act 7924, the Metro Manila Development Authority (MMDA) is mandated to provide solid waste disposal and management, and implement alternative programs and projects intended alternative programs and projects intended to reduce, reuse and recycle solid waste as well as the necessary logistical and operational support to its competent cities and municipality;

WHEREAS, Section 10 of Republic Act No. 9003, otherwise known as the "Ecological Solid Waste Management Act of 2000, "the LGUs shall be primarily responsible for the implementation and enforcement of the provisions of this Act within their respective jurisdictions. Segregation and collection of solid waste shall be conducted at the barangay level specifically for biodegradable, compostable and reusable wastes: Provided, that the collection of non-recyclable materials and special wastes shall be the responsibility of the municipality or city."

WHEREAS, the City of Muntinlupa (CGM), through a MOA with MMDA will be a recipient of a Bio Waste Converter with accessories such as shredder, squeezer and a leachate treatment system with one year supply of disinfectant and deodorizer worth Five Million Three Hundred Thousand Pesos (Php5,300,000.00);

WHEREAS, the Rapid Composter (Bio Waste Converter) and its accessories is being used at the Alabang Public Market, the latter being a huge generator of bio waste;

WHEREAS, the MOA states, among others, the CGM's obligation to designate a project team leader and members responsible for the operation and accountability of the equipment;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY REOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Hon. Rozzano Rufino B. Biazon to represent the City Government of Muntinlupa to enter and sign the Memorandum of Agreement (MOA) on the procurement, turn-over, operation and maintenance of a Bio-Waste Converter With Accessories to be used at the Alabang Public Market.

ADOPTED, by the 10th Sanggunian Panlungsod of Muntinlupa this 16th day of October 2023, on its 67th Regular Session.
