A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZANNO RUFINO B. BIAZON TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TOURISM-NATIONAL CAPITAL REGION (DOT-NCR) ON THE IMPLEMENTATION OF THE DOT-NCR'S DOMESTIC TOURISM PROJECTS THROUGH THE PROVISION OF THREE MILLION PESOS (PHP3,000,000.00) TO FUND THE CITY GOVERNMENT OF MUNTINLUPA'S TOURISM CIRCUIT AND CULTURAL DEVELOPMENT PLAN.

**WHEREAS**, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

**WHEREAS**, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.";

**WHEREAS**, in 2021, amid the pandemic, the demand for domestic tourism soared to a 38.16% (37,279,282 trips) growth compared to the 26,982,233 trips in 2020 with the National Capital Region accounting for 1,973,851 of the said trips;

**WHEREAS**, due to the demand for domestic tourism, the DOT implements the Domestic Tourism Program where financial and technical assistance is being granted to the Local Government Units (LGUs) for the preparation, implementation and monitoring of their tourism development plans;

**WHEREAS**, the City Government of Muntinlupa (CGM) submitted its tourism development plan amply called the Muntinlupa Tourism Circuit and Cultural Development Plan with a quantitative amount of **Three Million Pesos (Php3,000,000.00)**;

**WHEREAS**, the grant of **Three Million Pesos (Php3,000,000.00)**, accounted as a trust liability, to the CGM is subject to the reportorial requirements of the DOT;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Hon. Rozanno Rufino B. Biazon** to enter into a **Memorandum of Agreement (MOA)** with the **Department of Tourism-National Capital Region (DOT-NCR)** on the implementation of the DOT-NCR's **Domestic Tourism Projects** through the Provision Of **Three Million Pesos (Php3,000,000.00)** to fund the City Government of Muntinlupa's **Tourism Circuit and Cultural Development Plan**.
