WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that *"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."*

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, *"Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian."*

WHEREAS, the Sangguniang Panlungsod, through Resolution 2023-348, authorized the City Mayor Rozanno Rufino B. Biazon to represent the City Government of Muntinlupa in a memorandum of agreement with the Metro Manila Development Authority (MMDA) for the latter's donation of a Rapid Composter and its accessories,

WHEREAS, a Deed of Donation and Deed of Acceptance (DODA) is a necessary requisite for the processing of the donated equipment and its accessories;
