**A RESOLUTION AUTHORIZING THE CITY MAYOR ROZZANO RUFINO B. BIAZON IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE CITY GOVERNMENT OF SAN PEDRO REPRESENTED BY HON. MAYOR ART JOSEPH FRANCIS MERCADO, ON THE IMPLEMENTATION OF THE HOSPITAL FINANCIAL ASSISTANCE PROGRAM (HFAP), WHEREIN QUALIFIED BENEFICIARIES (RESIDENTS) OF THE CITY OF SAN PEDRO MAY SEEK IN-PATIENT, OUT-PATIENT, AND EMERGENCY SERVICES IN THE OSPITAL NG MUNTINLUPA (OSMUN) THROUGH A LETTER OF ENDORSEMENT (LOE)/GUARANTEE LETTER (GL).**

**WHEREAS**, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **“Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”**;

**WHEREAS**, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC (LGC-IRR), provides that, **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”**;

**WHEREAS**, RA 7160 likewise provides for the inter-local government units cooperation on grants, subsidies and other matters which are mutually beneficial for them;

**WHEREAS**, the **City Government of San Pedro Laguna (CGSPL)**, a neighboring local government unit, represented by its Local Chief Executive Hon. Mayor Art Joseph Francis Mercado, proposed an agreement to fortify the established partnership between the **City Government of Muntinlupa (CGM)** and CGSPL through the implementation of the latter's Hospital Financial Assistance Program (HFAP);

**WHEREAS**, Hon. City Mayor Mercado, pursuant to the authority granted by its Sangguniang Panlungsod Resolution No, 2023-41, may enter into agreements with, among others, **level 3 hospitals**;

**WHEREAS**, the HFAP will benefit the qualified beneficiaries/residents of the CGSPL who seek in-patient, out-patient, and emergency services in the Ospital ng Muntinlupa (OSMUN) , **a level 3 hospital subsidized and operated by the CGM**;

**WHEREAS**, under the terms of the Memorandum of Agreement, the CGM, shall receive a maximum of Twenty Thousand Pesos (Php20,000.00) per CGSPL-endorsed patient and a maximum of Two Hundred Thousand Pesos (Php200,000.00) per month in the discretion of the Office of the City Mayor CGMSPL, to cover the costs of **In-Patient, Out-Patient and Emergency Services**;

**WHEREAS**, the system of referrals of patients/ beneficiaries shall be covered by **Letter Of Endorsement (LOE) and/or Guarantee Letter (GL)** addressed to OSMUN, duly issued by the **Office Of The City Mayor, CGSPL** which shall include the specific amount that will be based on the net amount of final statement of account after deduction of benefits from **Philhealth, Malasakit Center, PCSO** and other government-sanctioned deductions;

**NOW THEREFOR, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to authorize the **City Mayor Rozzano Rufino B. Biazon** in behalf of the City Government of Muntinlupa to enter and sign the Memorandum of Agreement (MOA) with the City Government of San Pedro represented by Hon. Mayor Art Joseph Francis Mercado, on the implementation of the Hospital Financial Assistance Program (HFAP), **Wherein Qualified beneficiaries (Residents) of the City of San Pedro May Seek In-Patient, Out-Patient, and emergency services in the Ospital Ng Muntinlupa (OSMUN) through a Letter of Endorsement (LOE)/Guarantee Letter (GL).**
