WHEREAS, the **Barangay and Sangguniang Kabataan Elections (BSKE) 2023** was held simultaneously nationwide on the last Monday of October 2023 pursuant to Republic Act No. 11935 and the Supreme Court Decision in the case of *Macalintal v. Commission on Elections (G.R. Nos. 263590, 263673, 27 June 2023)*;

WHEREAS, **Honorable Councilor Luvi Pagsisihan Constantino, JD** emerged as the winning candidate for *Punongbarangay* of Barangay Cupang, Muntinlupa City in the BSKE 2023 and graced as the latter's first-ever female *Punongbarangay*;

WHEREAS, **Hon. Luvi Constantino** is a graduate of Bachelor of Science in Commerce Major in Management at the Santa Isabel College and earned her graduate studies degree in Jurisdoctor at the University of Perpetual Help System;

WHEREAS, tagged as "**Miss Instant Request**", she began her political career as elected Councilor of Muntinlupa City in 2007 and completed three consecutive terms thereafter until 2016. She returned to public service in 2022 after winning the Local Elections as City Councilor of Muntinlupa;

WHEREAS, equipped with competencies and a sense of leadership, **Hon. Luvi P. Constantino** was appointed as the Assistant Majority Floor Leader of the City Council from 2010 to 2016 and, during her terms, chaired the Committee on Ways and Means; Committee on Veterans, Elderly, Retirees, and Persons with Disability; and the Committee on Tourism, Culture, and Foreign Relations;
