ROMANDO S. ARTES, ON THE DONATION OF A MOBILE MATERIAL RECOVERY STORAGE, PURSUANT TO THE IMPLEMENTATION OF THE SECOND COMPONENT OF THE METRO MANILA FLOOD MANAGEMENT PROJECT (MMFMP) ON MINIMIZING SOLID WASTE IN WATERWAYS

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”**;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”**;

WHEREAS, by virtue of Republic Act 7924, the Metro Manila Development Authority (MMDA) is mandated to provide solid waste disposal and management, and implement alternative programs and projects intended to reduce, reuse and recycle solid waste as well as the necessary logistical and operational support to its competent cities and municipalities;

WHEREAS, The MMDA adopted the Metro Manila Flood Management Project (MMFMP), comprised of four(4) components which aimed to modernized thirty six (36) existing pumping stations and construction of Twenty (20) new ones and improvement of supporting infrastructure along critical waterways;

WHEREAS, the donation of Material Recovery Storage (MRS) is part of the **Second component which is for the Minimization Of Solid Ways In Waterways**, with the goal of carrying out activities that will improve the solid waste management system within the communities near the project drainage areas. It intends to introduce improved solid waste collection services, community mobilization and awareness incentive based improved waste collection with independently verified results, and neighborhood upgrading;

WHEREAS, the donated one (1) unit of MRS is worth **Forty Eight Thousand Eight Hundred Ninety Pesos (Php 48,890.00)** and shall be used at the **Alabang Central Public Market**. The conditions, obligations and rights of parties are laid down on the Memorandum of Agreement to which the City Legal Office interposed no objection;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY REOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon** to represent the City Government of Muntinlupa to enter into a **Memorandum of Agreement and Deed of Acceptance** with the **Metro Manila Development Authority (MMDA)** represented by **Atty. Romando S. Artes**, on the Donation of a **Mobile Material Recovery Storage**, pursuant to the implementation of the second component of the **Metro Manila Flood Management Project (MMFMP)** on minimizing solid waste in waterways

ADOPTED, by the 10th **Sanggunian Panlungsod of Muntinlupa** this 20th day of **November 2023**, on its 71st **Regular Session**.
