**WHEREAS**, in the five (5) years as **SK President, Sectoral Representative to the City Council**, he has been instrumental in the enactment/adoption of Ordinances and Resolutions from which he authored more than ten (10) significant legislations recognizing the relevance of youth empowerment including the increase in the cash incentives given to athletes, creation of the Local Youth Development Council, establishment of the Online Registration Program for Youths (ORPV), among others;
