**WHEREAS**, Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, *"Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"*

**WHEREAS**, pursuant to Article 99, 2 (i) of the LGC Implementing Rules and Regulations, the Sanggunian Panlungsod, *"Shall approve the annual and supplemental budgets of the city government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants;"*

**WHEREAS**, on September 7, 2023, the City Development Council (CDC) pursuant to its mandate to appraise and prioritize socio-economic development programs and projects of the local government unit, adopted Resolution No. 04 Series of 2023 also known as, *"A Resolution adopting the Supplemental Annual Investment Program (AIP) No. 4 and its Supplemental Budget for FY 2023 and favorably endorsing the same to the Sangguniang Panlungsod;"*

**WHEREAS**, the City Government of Muntinlupa has an **Unexpended Balance** in the amount of **Forty-Five Million Pesos (Php45,000,000.00)** as certified by the City Accountant and the City Treasurer;
