WHEREAS, Section 16 of Republic Act No. 7160 (Local Government Code of 1991), mandates all local government units to ensure and maintain peace and order within their respective areas, among other concerns;

WHEREAS, pursuant to Executive Order No. 773, series of 2009, as amended, the Muntinlupa City Peace and Order Council (CPOC) shall plan and implement measures which will further improve the peace and order and public safety within their area of responsibility, and to monitor peace and order and public safety (POPS) situation;

WHEREAS, on 09 January 2023, the Sangguniang Panlungsod ng Muntinlupa adopted City Resolution No. 2023-172 otherwise known as "A Resolution Adopting the Peace and Order and Public Safety (POPS) Plan for Calendar Year 2023-2025 of the City of Muntinlupa";

WHEREAS, the Muntinlupa City POPS Plan 2023-2025, is a term-based plan that contains LGU programs, projects and activities that address local peace and order and public safety concerns;

WHEREAS, DiLG Memorandum Circular No. 2022-118 entitled "Guidelines on the Development and Formulation of the Peace and Order and Public Safety Plan (POPS-PLAN) 2023-2025" provides that should there be a need to revise the POPS Plan, the same process in approving the POPS Plan will be followed including the endorsement of the Plan, through a POC Resolution, to the Local Sanggunian for adoption and to ensure funding;
