TRESVALLES, ON THE DEPLOYMENT OF THE DOST-DEVELOPED FOOD TECHNOLOGY IN SUPPORT OF THE KALINGANG MUNTI COMMUNITY NUTRITION ENHANCEMENT INITIATIVE (KMCNEI)

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, *“every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC (LGC-IRR), provides that, *“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”*;

WHEREAS, Executive Order No. 128 mandates the Department of Science and Technology (DOST) to provide central direction, leadership and coordination of scientific and technological efforts and ensure that the results therefrom are geared and utilized in areas of maximum economic and social benefits for the people;

WHEREAS, DOST-NCR, regional office of the DOST, promotes the nutrition and health pillars and is being implemented through Community Empowerment through Science and Technology (CEST) where food Innovation is being undertaken to improve the general well-being and quality of life by promotion of healthy lifestyle, disease prevention and reduction of health disparities;

WHEREAS, the City Government of Muntinlupa (CGM), under the Kalusugan agenda, envisions an accessible health services to the constituency. In furtherance thereto, the CGM has, among its other health programs, the *Kalingang Munti Community Nutrition Enhancement Initiative* aimed to address the pressing needs of its most disadvantaged constituents and improve their nutritional status;

WHEREAS, the DOST, through its Food and Nutrition Research Institute has developed food technologies such as Enhanced Nutribun, Rice Mongo Curis and KamoTea which will be deployed to Muntinlupa, targeting indigent families with pregnant/lactating mothers, children and senior citizens in Barangays Poblacion, Putatan, Cupang and Sucat;

WHEREAS, the undertaking, with **One Million Seventeen Thousand Nine Hundred Pesos (Php1,017,900.00)** cost to the CGM, shall likewise entail the training of CGM's personnel who will facilitate the program;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, authorizing the Hon. City Mayor **Rozzano Rufino B. Biazon**, to enter and sign the MOA with Department of Science and Technology – National Capital Region (DOST-NCR) represented by Director **Romelen T. Tresvalles**, on the deployment of *DOST-Developed Food Technology* to support the *Kalingang Munti Community Nutrition Enhancement Initiative (KMCNEI)* of the City of Muntinlupa.






