**WHEREAS**, Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government code of 1991, provides that, "*The city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance*";

**WHEREAS**, Section 458, supra, mandates the Sangguniang Panlungsod, as the legislative body of the city, "*To enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants and in the proper exercise of the corporate powers of the city, shall approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities, and in addition to said services and facilities, shall establish a scholarship fund for the poor but deserving students in schools located within its jurisdiction;*"

**WHEREAS**, the Local Finance Committee (LFC) of the City of Muntinlupa, resolved on November 10, 2023 Resolution No. 11 Series of 2023 or a Resolution Recommending the Approval of the Fund Disbursement Service (FDS) Implementing Agreement between G-Xchange (GXI Phils/GCash) and the City Government of Muntinlupa-Muntinlupa Scholarship Division (CGM-MSD);

**WHEREAS**, among others, the LFC Resolution cites that there are Six Thousand (6,000) college scholars and other MSD beneficiaries who, upon enrollment to the digital wallet such as GCash, will benefit in the contact-less and efficient disbursement of the scholarship fund;



**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon** to represent Muntinlupa in an **Implementing Agreement** on **Fund Disbursement Service (FDS)** with G-Xchange, Inc, represented by its Head of Enterprise and Public Sector **Jose Luis G. Reyes**, for the Disbursement of Allowance or Financial Assistance to Muntinlupa Scholarship Program Scholars/Beneficiaries.


