A RESOLUTION AUTHORIZING THE CITY MAYOR ROZZANO RUFINO B. BIAZON IN BEHALF OF THE CITY OF MUNTINLUPA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH J. ACLAN MEDICAL AND DIAGNOSTIC CLINIC, INC, ALSO KNOWN AS HOME LAB MEDICAL AND DIAGNOSTIC SERVICES (HOMELAB) REPRESENTED BY JOHN PAUL L. ACLAN ON THE IMPLEMENTATION OF MEDICAL SERVICES UNDER THE KONSULTA PACKAGE OF PHILIPPINE HEALTH INSURANCE (PHILHEALTH) IN COMPLIANCE WITH THE UNIVERSAL HEALTH CARE INTEGRATION SITE.

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-IRR), provides that, "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."

WHEREAS, PhilHealth's Konsulta (Konsultasyong Sulit Tama) Program, a vital initiative aimed at providing preventive healthcare services to its members under the Universal Health Care Law, offers a multitude of life-saving benefits that ensure access to quality healthcare;

WHEREAS, the City Government of Muntinlupa under the Kalusugan cluster of its 7K agenda takes part in the implementation of the Universal Health Care Law through partnership with third party health provider such as the **J. Aclan Medical And Diagnostic Clinic, Inc, also Known As Home Lab Medical And Medical And Diagnostic Services (Homelab)**;

WHEREAS, for a period of one year, the CGM shall refer Muntinlupa constituents who are member of Philhealth to HOMELAB and the latter shall provide medical, diagnostic, laboratory and other health services included in the Konsulta Package;

WHEREAS, subject to the guidelines to be formulated by the implementing office, the services of HOMELAB shall be paid by the CGM which amount/ cost shall come from the Philhealth Capitation;

WHEREAS, initially, there are five (5) Muntinlupa Health Centers which will process the needed health services under the Konsulta Package;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **City Mayor Rozzano Rufino B. Biazon** in behalf of the City of Muntinlupa to enter into a Memorandum of Agreement with **J. Aclan Medical and Diagnostic Clinic, Inc**, also known as **Home Lab Medical and Diagnostic Services (HomeLab)** represented by **John Paul L. Aclan** on the implementation of medical services under the **Konsulta Package** of **Philippine Health Insurance (Philhealth)** in compliance with the **Universal Health Care Integration Site**.

ADOPTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **11th day of December 2023**, on its **74th Regular Session**.
