



WHEREAS, the National Nutrition Council (NNC) on January 12, 2012 adopted the NNC Governing Board Resolution (GBR) No. 2, Series of 2013 which approved the Revised Implementation Guidelines on the **Operation Timbang Plus (OPT Plus)** and underscored the vital role of nutrition in the over-all health of each individual;

WHEREAS, growth assessment of children ages 0-71 month is being done by employing the two methods namely: a) Growth monitoring promotion (GMP) services provided by health workers, and c) **Operation Timbang Plus or OPT Plus** done every first quarter of the year in communities nationwide;

WHEREAS, OPT Plus, aims to provide specific guideposts for the conduct, processing, analysis of data, shared with the Nutrition Committees to help generate timely, accurate and important nutrition information about children 0-71 months old, information which are essential in the formulation of plans and policy in support of the local Plan of Action for Nutrition;

WHEREAS, on June 27, 2023, the City Government of Muntinlupa, through its City Nutrition Committee, adopted Resolution No. 01 Series of 2023 on The New Guidelines For Operation Timbang Plus, among others;

WHEREAS, the adoption of the guidelines on OPT Plus is pursuant to the Muntinlupa CNC's mandate to promote the growth or increase in the size as a result of the child's intake of food and maintenance of a child's overall health and well-being through acceptable growth standards;
