#### Contract Agreement

THIS AGREEMENT made the Sign day of January 20 24 between CITY GOVERNMENT OF MUNTINLUPA of the Philippines (hereinafter called "the Entity") of the one part and HUMIL INTERNATIONAL CORPORATION with address at Sampaloc Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Supply, Delivery & Installation of Laboratory Equipment to be used by CDM** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Eight Hundred Twenty Three Thousand Nine Hundred Pesos (P1,823,900.00)**(hereinafter called "the Contract Price").

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- The City Government of Muntinlupa agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


