#### Contract Agreement

WHEREAS, the Entity is desirous that the Contractor execute **Completion of Sucat Senior High School Site Development at Brgy. Sucat, Muntinlupa /10324277** (hereinafter called "the Works") and the Entity has accepted the Bid for **Thirty Seven Million Five Hundred Ten Thousand Six Hundred Forty Pesos & 73/100** (**P37,510,640.73**) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.</u>




