MUNTINLUPA with address at City Hall, National Road, Putatan, Muntinlupa City, (hereinafter called the
"Entity") and JADOMINIA CONSTRUCTION & SUPPLIES with address at Biñan, Laguna (hereinafte
called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute Construction of Drainage System at Villa Carolina II Subd. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
