INVITATION TO BID FOR THE SUPPLY & DELIVERY OF MEALS FOR VARIOUS PROGRAMS & ACTIVITIES

1. The *City Government of Muntinlupa*, through its duly approved **2024 Executive Budget** intends to apply the sum of **One Million Six Hundred Thirty Thousand Nine Hundred Thirty Pesos (P1,630,930.00)** being the ABC to payments under the contract for **Supply & Delivery of Meals for Various Programs & Activities/699 & 899**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The City Government of Muntinlupa now invites bids for the above Procurement Project. Delivery of the Goods is required within **1 year (based on schedule of event/activities) but start of delivery is 15 days from the issuance of the Notice to Proceed**.. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
5. Prospective Bidders may obtain further information from CGM BAC Secretariat through contact details given below and inspect the Bidding Documents at the address given below during office hours 8am to 5pm.
6. A complete set of Bidding Documents may be acquired by interested Bidders on **April 1, 2024** from the given address and website(s) below and upon payment of a fee in the amount of **Five Thousand Pesos(P5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees which will be presented in person, by facsimile or through electronic means.
7. The City Government of Muntinlupa will hold a Pre-Bid Conference on **April 10, 2024**, 8:30 a.m. Audio Visual Room, 2/F City Hall Main Building, National Road, Putatan, Muntinlupa City, which shall be open to prospective bidders.

8. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **April 23, 2024**, 8:00 a.m. Late bids shall not be accepted.
9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
10. Bid opening shall be on **April 23, 2024**, 9:00 a.m. Audio Visual Room, 2/F City Hall Main Building, National Road, Putatan, Muntinlupa City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The City Government of Muntinlupa reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
