EXECUTIVE ORDER No. 19
Series of 2023

**PROVIDING FOR AMENDMENTS TO EXECUTIVE ORDER No. 30, SERIES OF 2016,
ON THE RE-CREATION AND RE-COMPOSITION OF
THE MUNTINLUPA CITY NUTRITION COMMITTEE**

WHEREAS, Executive Order No. 30, Series of 2016, issued on 20 December 2016, provided for the creation of the Muntinlupa City Nutrition Committee, Its Composition and Functions;

WHEREAS, City Ordinance No. 2022-036 was enacted by the Sangguniang Panlungsod ng Muntinlupa, amended City Ordinance No. 19-239, and provided for the composition of the Muntinlupa City Nutrition Committee;

WHEREAS, the City of Muntinlupa, in recent years, has received recognition for its remarkable efforts to stem the tide of malnutrition and to implement sound nutrition programs for the welfare of its younger population;

WHEREAS, in 2022, the City of Muntinlupa received the Green Banner Seal of Compliance Award, the Best Local Government Unit (LGU) in the Compliance to and Dissemination of National Laws and Issuances on Nutrition, the Best in Nutrition in Emergencies Program, the Best Regional Nutrition Action Officer of the Year for Magdalena C. Meana, MD, MPH, the Regional Nutrition Program Coordinator of the Year (National Capital Region) for Maria Ana C. Ordenes, RND, MSN, and the Regional Outstanding Barangay Nutrition Scholar of the Year (Finalist, National Capital Region) for Velma S. Cadungog;

WHEREAS, recent changes in the appointment of officers of the City Government of Muntinlupa (CGM), as well as National Government Agencies (NAs), necessitate the introduction of amendments to Executive Order No. 30, Series of 2016;

WHEREAS, strong effort to continue making the Muntinlupa City Nutrition Committee relevant, responsive and dynamic is imperative, and it starts with fortifying the composition thereof;

NOW, THEREFORE, I, Rozzano Rufino B. Biazon, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Re-Creation and Re-Composition.

Membership in the MCNC, among public officials and officers, is a function of their respective office. As such, the resignation, removal, transfer, termination, severe incapacity, grave illness, death, or any other similarly-situated circumstance of the member shall entitle the successor to assume membership without the need for the issuance of another order or instrument.

For those from the private sector, in any of the circumstances above-mentioned, the successor shall be named by the City Mayor from a list of individuals that the remaining members have identified and submitted for consideration. They shall be bound by the same measure, as those from the public sector, of fidelity, accountability and integrity.

Section 2. Functions.

Functions enumerated under City Ordinance No. 2022-036 are herein repleaded, and are made an integral part of this Executive Order.

Section 3. Secretariat.

The Secretariat shall be composed of the following individuals, namely:

- (a) Lea Faith M. Macabulos, RND;
(b) Mary Joy A. Pereña, RND; and
(c) Camille G. Gamayao, RND.

The functions of the Secretariat are enumerated under Section 6 (Nutrition Secretariat) of City Ordinance No. 2022-036, and are made an integral part of this Executive Order.

Section 4. Monitoring and Evaluation.

The MCNC shall appoint the individuals who shall comprise the core group as provided under Section 7 of City Ordinance No. 2022-036, and the same core group shall perform the functions as provided therein.

Section 5. Allowances.

The amount of allowances for each member of the MCNC and the Secretariat shall be drawn from the Annual Investment Plan (AIP) of the City Health Office as provided under Section 8 of City Ordinance No. 2022-036. Likewise, the conditions set forth therein shall be followed.

Section 6. Repealing Clause.

All previously issued orders that run counter to any provision found herein shall be deemed repealed, revoked, or amended accordingly.

Section 7. Separability Clause.

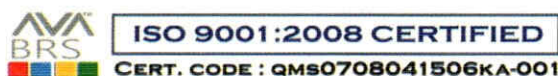
In the event any provision found herein shall be judicially decided illegal or administratively declared infirm, untouched provisions shall continue to have full force and effect.

Section 8. Effectivity Clause.

This Executive Order shall take effect immediately upon its signing, and it shall continue to have full force and effect until repealed, revoked, or amended accordingly.
