EXECUTIVE ORDER No. 29
Series of 2023

**PROVIDING FOR AMENDMENT TO EXECUTIVE ORDER NO. 29, SERIES OF 2023,
AS AMENDED BY EXECUTIVE ORDER NO. 21, SERIES OF 2019,
EXECUTIVE ORDER NOS. 3 AND 3-A, SERIES OF 2014,
ON THE APPOINTMENT OF ATTY. IAN BENJAMIN N. TAN
AS INVESTIGATOR OF THE PEOPLE'S LAW ENFORCEMENT BOARD
OF THE CITY OF MUNTINLUPA**

WHEREAS, Section 66 (a) of Republic Act. No. 8551 provides for the creation of People's Law Enforcement Board (PLEB) in every city and municipality and shall be the central receiving entity for any citizen's complaint against the officers and members of Philippine National Police;

WHEREAS, Sangguniang Panlungsod Resolution No. 14-053 dated February 3, 2014, created the City of Muntinlupa's People's Law Enforcement Board (PLEB);

WHEREAS, the PLEB is a vital check and balance mechanism by which our law enforcers are held accountable to the people in the community where they serve, and help the Philippine National Police in upholding confidence of the people in the Police organization;

WHEREAS, the City Mayor issued Executive Order No. 35, Series of 2022-B, reorganizing the PLEB-Muntinlupa City in compliance with Republic Act No. 6975, as amended by Republic Act No. 8551;

WHEREAS, Section 1 of the said Executive Order provides for the composition of the Board as prescribed by law, and further expanded this to include a PLEB Investigator who is responsible for conducting preliminary investigation by interviewing complainants and conducting research on whether the case being filed has probable cause;

WHEREAS, the designation of Investigator is imperative because the conduct of preliminary investigation before contesting parties are summoned to a hearing would save time and energy not only on the Board Members but more so on the involved parties;


WHEREAS, in view of the passing away of PLEB Investigator Atty. Tomas J. Caspe on 13 February 2023, the appointment of a new PLEB Investigator becomes imperative;

WHEREAS, after thorough deliberation and assessment of the qualifications of Atty. Ian Benjamin N. Tan, the Board recommends his appointment to fill up the vacated position and complete the term of the late Atty. Caspe, which is the subject of Resolution No. 2023-04, Series of 2023, issued by the PLEB, and dated 12 May 2023;

NOW, THEREFORE, I, Rozzano Rufino B. Biazon, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby approve the recommendation of the PLEB of Muntinlupa, chaired by Atty. Victor C. Lizardo, and hereby appoint Atty. Ian Benjamin N. Tan as Investigator of the People's Law Enforcement Board (PLEB) of the City of Muntinlupa to serve for the remaining term of the late Atty. Caspe.

This Executive Order shall take effect immediately upon its signing, and it shall remain in full force and effect until revoked, rescinded, or amended accordingly.
