PROVIDING FOR INTRODUCTION OF AMENDMENT TO
SECTION 1 OF EXECUTIVE ORDER NO. 49, SERIES OF 2022,
WHICH GRANTED THE RECONSTITUTION OF
THE PROJECT MONITORING COMMITTEE UNDER
THE LOCAL DEVELOPMENT COUNCIL OF THE CITY OF MUNTINLUPA,
ITS COMPOSITION AND FUNCTIONS

WHEREAS, Section 1 of Executive Order No. 49, Series of 2022, provides for the composition of the Project Monitoring Committee (PMC) under the Local Development Council of the City of Muntinlupa;

WHEREAS, there is a need to add to the nine (9) names of individuals enumerated therein, specifically Arch. Beaudon D. Causapin, of the Office of the City Architect, as his inputs thereto significantly contribute to the successful discharge of the functions of the PMC;

NOW, THEREFORE, I, Rozzano Rufino B. Biazon, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Amendment to Section 1 of Executive Order No. 49, Series of 2022.

Section 1 of Executive Order No. 49, Series of 2022, is hereby amended to read as follows:

Section 1. Reconstitution and Re-composition.

The Project Monitoring Committee (PMC, for brevity) of the City of Muntinlupa is hereby reconstituted under the Local Development Council, and it shall be composed of the following individuals, with their respective designations, namely:

In the event that any provision found herein is judicially decided illegal, or administratively declared infirm, untouched provisions shall remain in full force and effect.






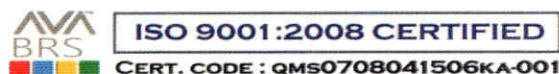
