EXECUTIVE ORDER No. 37
Series of 2023

**PROVIDING FOR AMENDMENTS TO EXECUTIVE ORDER NO. 50, SERIES OF 2023-B,
ON THE RE-COMPOSITION OF THE MENTAL HEALTH COMMITTEE OF
THE CITY OF MUNTINLUPA, ITS COMPOSITION AND FUNCTIONS**

WHEREAS, Executive Order No. 50, Series of 2022-B, entitled "*Providing for the Creation of the Mental Health Committee of the City of Muntinlupa, its Composition and Functions*," was approved and issued by Rozzano Rufino B. Biazon, City Mayor, on 08 November 2023;

WHEREAS, in order to effectively implement the community and school-based mental health programs of the City of Muntinlupa, the Mental Health Committee needs to have additional members who shall implement mental health programs and services, widen its reach, and provide support to more beneficiaries;

WHEREAS, the expansion of the Committee's composition addresses the need for a comprehensive and integrative mental health program and services that are responsive and relevant to the needs of the people of Muntinlupa at the community and school level;

WHEREAS, the additional members of the Mental Health Committee shall fulfill the functions as stated in the Executive Order;

NOW, THEREFORE, I, Rozzano Rufino B. Biazon, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Re-Composition.

The Mental Health Committee (MHC, for brevity) of the City of Muntinlupa is hereby re-composed as follows, namely:

Membership in the MHC, among public officials, is a function of the office which the member occupies. Hence, the resignation, removal, retirement, termination, transfer, severe illness, grave incapacity, death or any other similarly-situated circumstance of the member shall entitle the successor to assume membership without the need for the issuance of another instrument.

Members from the private sector shall be governed by the same measure of fidelity, accountability and integrity. In the event any of the above-enumerated circumstance befalls such member, the remaining members of the MHC shall submit a list of names and recommend the successor to the City Mayor for eventual selection.

Section 2. Repealing Clause.

Any previously issued order found inconsistent with the provisions found herein shall be deemed repealed, revoked, or amended accordingly.


Section 3. Separability Clause.

In the event any provision found herein is judicially decided illegal or administratively declared infirm, untouched provisions shall remain in full force and effect.

Section 4. Effectivity Clause.

This Executive Order shall take effect immediately upon its signing, and it shall remain in full force and effect until repealed, revoked, or amended accordingly.
