EXECUTIVE ORDER No. 45
Series of 2023

PROVIDING FOR THE IMPOSITION OF A LIQUOR BAN WITHIN A FIVE HUNDRED-METER RADIUS FROM SAN BEDA COLLEGE ALABANG FOR THE ORDERLY AND SAFE CONDUCT OF THE 2023 BAR EXAMINATIONS

WHEREAS, Section 455 (b) (2) (iii) and (v) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the City Mayor shall

(2) Enforce all laws and ordinances relative to the governance of the city and in the exercise of the appropriate corporate powers provides for under Section 22 of this Code, implement all approved policies, programs, projects, services and activities of the city, and, in addition to the foregoing, shall:

(iii) Issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

(v) Act as the deputized representative of the National Police Commission, formulate the peace and order plan of the city, and, upon its approval, implement the same; and, as such, exercise general and operational control and supervision over the local police forces in the city, in accordance with Republic Act No. 6975;"

WHEREAS, on 18 July 2023, the Supreme Court of the Philippines, through Associate Justice Ramon Paul L. Hernando, 2023 Bar Examinations Chairperson, and San Beda College Alabang (SBCA), represented by Atty. Ulpiano P. Sarmiento III, Dean of the College of Law and Fr. Gerardo Ma. De Villa, OSB, signed a contract designating the SBCA as the Headquarters of the 2023 Bar Examinations, which will be held on 17, 20 and 24 September 2023;

WHEREAS, to ensure the orderly and safe conduct of the said examinations, there is a need to ban liquor within a five hundred (500)-meter radius from San Beda College Alabang, Barangay Cupang;

NOW, THEREFORE, I, Rozanno Rufino B. Biazon, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Definition of Liquor Ban.

Liquor ban shall refer to the marketing, distribution, and/or consumption of any beverage or drink with alcohol content.

Section 2. Imposition.

A liquor ban shall be imposed within a five hundred (500) meter radius from San Beda College Alabang, Barangay Cupang, City of Muntinlupa, on the following time frame and dates, namely:

- (a) 9:00 p.m. of 16 September 2023 to 10:00 p.m. of 17 September 2023;
- (b) 9:00 p.m. of 19 September 2023 to 10:00 p.m. of 20 September 2023; and
- (c) 9:00 p.m. of 23 September 2023 to 10:00 p.m. of 24 September 2023.

Section 3. Enforcement.

Personnel of the following agencies and offices shall be deputized to investigate, follow through, apprehend, and file the requisite case, if warranted, against any individual who shall be found in violation of this directive, namely:

- (a) Philippine National Police, Muntinlupa City Station;
- (b) Public Order and Safety Office;
- (c) City Security Office;
- (d) Muntinlupa Traffic Management Bureau;
- (e) Barangay Governments of Cupang, Alabang and Ayala Alabang.

Section 4. Repealing Clause.

Any previously issued order inconsistent with any provision found herein shall be deemed repealed, revoked, or amended accordingly.


Section 5. Separability Clause.

In the event any provision found herein is judicially decided illegal or administratively declared infirm, untouched provisions shall remain in full force and effect.

Section 6. Effectivity Clause.

This Executive Order shall take effect immediately upon its signing, and it shall be in full force and effect until repealed, revoked, or amended accordingly.
