#### Contract Agreement

THIS AGREEMENT, made this 10 2024 \_\_\_\_\_\_, 2024 between CITY GOVERNMENT OF MUNTINLUPA with address at City Hall, National Road, Putatan, Muntinlupa City, (hereinafter called the "Entity") and RS CIRCLELINK CONST. CO. with address at Baccor Cavite (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Construction of Steel Railings** at Centennial Avenue Laguerta Tunasan/10609179 (hereinafter called "the Works") and the Entity has accepted the Bid for One Million Three Hundred Ninety Six Thousand Eight Hundred Seventy Three Pesos & 80/100 (P1,396,873.80) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

#### NOW THIS AGRÉEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
