AN ORDINANCE GRANTING THE TOTAL AMOUNT OF THREE THOUSAND PESOS (PHP3,000.00) OF FINANCIAL ASSISTANCE TO MS. PEARLY GRACE P. PANUGAN AFFECTED BY FIRE ON FEBRUARY 13, 2024, LOCATED AT 046 SITIO SALVACION, BARANGAY TUNASAN, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on **February 13, 2024** one (1) structure, housing one (1) family, were gutted by fire at **046 Sitio Salvacion, Barangay Tunasan, Muntinlupa City**;

WHEREAS, in a final report rendered by the **Social Services Department** on **February 14, 2024**, and received by the **SP Secretariat Office** on **February 16, 2024** the following were noted as casualties of the said fire:

1. **One (1) structure;**
2. **One (1) family;**
3. **Five (5) individuals;**
4. **1 Child (0-5 years old);**

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Tunasan**, conducted a survey on the victims of the fire to determine the homeowner basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance amount of **Three Thousand Pesos (Php3,000.00)** to **Ms. Pearly Grace P. Panugan**;

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of **Three Thousand Pesos (Php3,000.00)** of Financial Assistance to **Ms. Pearly Grace P. Panugan** affected by fire on **February 13, 2024** located at **046 Sitio Salvacion, Barangay Tunasan, Muntinlupa City**.

ENACTED FURTHER, that the **Final Disaster Report** dated **February 14, 2024**, of the **Social Services Department (SSD)** shall be charge to the **70% Quick Response Fund (QRF)** from the **Department of Disaster Resilience and Management (DDRM)** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code of Other MOOE: 5-02-99-990**, with **CN: 2024-06** shall form part of this ordinance.
