WHEREAS, on February 7, 2024 one (1) structure, housing one (1) family, were gutted by fire at No. 7, MLQ Street, Barangay Cupang, Muntinlupa City;

WHEREAS, in a final report rendered by the Social Services Department on February 8, 2024, and received by the SP Secretariat Office on February 15, 2024 the following were noted as casualties of the said fire:

1. One (1) structure;

2. One (1) family;

3. Four (4) individuals;
