WHEREAS, on February 20, 2024 one (1) structure, housing one (1) family, was gutted by fire at Sitio Anahaw, 7A Extension, Barangay Alabang, Muntinlupa City;

WHEREAS, in a final report rendered by the Social Services Department on February 21, 2024, and received by the SP Secretariat Office on February 21, 2024 the following were noted as casualties of the said fire:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 10th Sangguniang Panlungsod, to grant the total amount of Three Thousand Pesos (Php3,000.00) of Financial Assistance to Mr. Alex Signapan Barocaboc affected by fire on February 20, 2024 located at Sitio Anahaw, 7A Extension, Barangay Alabang, Muntinlupa City.

ENACTED FURTHER, that the Final Disaster Report dated February 21, 2024, of the Social Services Department (SSD) shall be charge to the 70% Quick Response Fund (QRF) from the Department of Disaster Resilience and Management (DDRM) with AIP Reference 1000-001-2-921-150-005-001 and Account Code of Other MOOE: 5-02-99-990, with CN: 2024-09 shall form part of this ordinance.
