WHEREAS, on January 11, 2024 One (1) structure, housing one (1) family, were gutted by fire at No. #102 Purok 1, Block 7, Bautista Street, Barangay Bayanan, Muntinlupa City;

WHEREAS, in a final report rendered by the Social Services Department on January 11, 2024, and received by the SP Secretariat Office on January 11, 2024 the following were noted as casualties of the said fire:
