WHEREAS, Section 458 of Republic Act No. 7160, otherwise known as the New Local Government Code of 1991, states that, ***"Xxx shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants, xxx;"***

WHEREAS, likewise Section 458 (viii) of the same Code, states that, ***"empowers the Sanggunian to determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees wholly or mainly from city funds;"***

WHEREAS, Article 99(1)(ix) of Rules and Regulations Implementing LGC of 1991, states that, ***"When finances of the Local Government allow, provide for additional allowances and other benefits to Judges, Prosecutors, xxx and other government officials stationed in or assigned to the city;"***

WHEREAS, on January 3, 2024, the Local Finance Committee adopted Resolution No. 02-2024, entitled, ***"A Resolution recommending the granting of financial assistance to the members of COMELEC Muntinlupa City who have rendered election services in the 2023 Barangay and Sangguniang Kabataan Elections."***

WHEREAS, in order to ensure the orderly and peaceful conduct of the Barangay and Sangguniang Kabataan Election, the Commission on Elections-Muntinlupa Office has also tapped the services of additional personnel from other offices, in assisting and coordinating in the preparation of the said elections;

WHEREAS, the Budget Office certified that there is an available fund from the 2023 Executive Budget under the Office of the City Mayor;

NOW BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the **10th Sangguniang Panlungsod of Muntinlupa**, in Session assembled that:

SECTION 1. Title – this ordinance shall be known as An Ordinance granting Financial Assistance to the Comelec Officials and Staff, and Other Support Personnel who served in the Barangay and Sangguniang Kabataan Election (BSKE) on **October 30, 2024** in the City of Muntinlupa.

SECTION 2. Rates of entitled Personnel. There are twenty-three (23) COMELEC and staff, and other support personnel who served during the Barangay and Sangguniang Kabataan Elections 2023 as provided by the COMELEC Local Chief, and who shall receive the designated amount, to wit:

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **15th day of January 2024**, on its **78th Regular Session**.




