**AN ORDINANCE GRANTING A FINANCIAL ASSISTANCE AMOUNTING TO ONE MILLION PESOS (PHP1,000,000.00) TO THE MUNICIPAL GOVERNMENT OF CARAGA, DAVAO ORIENTAL WHICH IS PLACED UNDER THE STATE OF CALAMITY CAUSED BY THE "TROPICAL DEPRESSION KABAYAN" SINCE DECEMBER 18, 2023, AND SUCH AMOUNT SHALL BE TAKEN FROM THE 2024 EXECUTIVE BUDGET UNDER LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND – 30% QUICK RESPONSE FUND**

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the "Local Government Code of 199," provides that **"every local government Unit shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare"**;

**WHEREAS**, Section 21 of Republic Act No. 10121, otherwise known as the "Philippine Risk Reduction Management Act 2010," provides that **"Upon the recommendation of the Local Disaster Risk Reduction Management Office (LDRRMO) and approval of the sanggunian concerned, the Local Disaster Risk Reduction Management Council (LDRRMC) may transfer the said fund to support disaster risk reduction work of other LDRRMCs which are declared under state of calamity"**;

**WHEREAS**, Section 21 (2) of Republic Act No. 10121 imparts a "Quick Response Fund (QRF)" intended for **"relief and recovery programs in order that the situation and living conditions of people in communities or areas stricken by disaster calamities, epidemic, or complex emergencies, may be normalized as quickly as possible"**;

WHEREAS, the Sangguniang Bayan of the Municipality of Caraga adopted Resolution No. 148, Series of 2023, *declaring the Municipality of Caraga, Davao Oriental under the State of Calamity due to the damages caused by the continuous heavy and intense rainfall, which triggered massive flooding brought about by the Tropical Depression "Kabayan"*;

WHEREAS, the aforementioned Resolution No. 148, Series of 2023, provides that *"Based on the progress report submitted by the MDRRM Office of the Municipality of Caraga, there are 6,210 families that were greatly affected by the said weather condition wherein ten (10) out of seventeen (17) barangays have initially reported damages within the area of jurisdiction, namely: Barangays Poblacion, San Pedro, Lamiawan, D.L. Balante, San Antonio, Pichon, San Jose, San Luis, and Alviar"*;

WHEREAS, based on report, Tropical Depression "Kabayan" caused severe impacts and widespread destruction to agricultural crops, livestock, several residential houses, roads, bridges, and other infrastructures in the Municipality of Caraga which greatly affected **6,210 families from ten (10) out of seventeen (17) barangays**, namely: Barangays Poblacion, San Pedro, Lamiawan, D.L. Balante, San Antonio, Pichon, San Jose, San Luis, and Alvar";

WHEREAS, Mayor Ronie S. Osnan of the Municipality of Caraga, Davao Oriental, on a letter addressed to Mayor Rozzano Rufino B. Biazon, dated 31 January 2024, requested the financial assistance from the City Government of Muntinlupa and the Muntinlupa City Department of Disaster Resilience and Management (MDDRM);

WHEREAS, on 23 February 2024, Mayor Biazon duly-endorsed to the Sangguniang Panlungsod ng Muntinlupa the grant of financial assistance amounting to PhP1,000,000.00 to the Municipal Government of Caraga, which amount shall be sourced from the City's Local DRRM Office Quick Response Fund (30%);

NOW THEREFORE, BE IT ENACTED, by the 10<sup>th</sup> Sangguniang Panlungsod in Session assembled that:

**SECTION 1. Title.** This Ordinance shall be known as, *"An Ordinance Granting a Financial Assistance Amounting to One Million Pesos (Php1,000,000.00) to the Municipal Government of Caraga, Davao Oriental which is Placed Under the State of Calamity Caused by the "Tropical Depression Kabayan" since December 18, 2023, and such amount shall be taken from the 2024 Executive Budget under Local Disaster Risk Reduction and Management Fund- 30% Quick Response Fund.*

**SECTION 2. Implementation.** The Muntinlupa City Department of Disaster Resilience and Management (MDDRM) shall mainly facilitate the processing of all necessary documentary, budgeting, and accounting requirements for the purpose of this Ordinance until the assistance has been duly-received by the beneficiary.

**SECTION 3. Budgeting.** The financial assistance in the total amount of **One Million Pesos (PhP1,000,000.00)** to Municipal Government of Caraga, Davao Oriental shall be taken from the **2024 Executive Budget under the Local Disaster Risk Reduction and Management Fund – 30% Quick Response Fund.**

**SECTION 4. Publication and Dissemination.** The Ordinance shall be published pursuant to the requirements of the Local Government Code and shall be posted in the Official Website of the City Government of Muntinlupa. The **Public Information Office (PIO)** shall disseminate copies of this Ordinance in all available social media platforms.

**SECTION 5. Separability Clause.** If any portion of this Ordinance is declared invalid, the remainder of this Ordinance shall not be affected and shall remain valid and enforceable.

**SECTION 6. Repealing Clause.** All ordinances, rules, and regulations or part thereof where provisions are in conflict or contrary to the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.

**SECTION 7. Effectivity.** This Ordinance shall take effect upon its approval and after complying with the publication requirements of the law.

**ENACTED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this **26<sup>th</sup>** day of **February 2024**, on its **84<sup>th</sup> Regular Session.**
