WHEREAS, Section 16 of the Local Government Code of 1991 states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare":

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, "The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx";

WHEREAS, on February 28, 2024 one (1) structure, housing one (1) family, were gutted by fire at No. 25 Cadiz Street, Alabang Hills, Barangay Cupang, Muntinlupa City;

WHEREAS, in a final report rendered by the Social Services Department on February 29, 2024, and received by the SP Secretariat Office on March 5, 2024 the following were noted as casualties of the said fire:

- 1. One (1) structure;
- 2. One (1) family;
- 3. Six (6) individuals;

WHEREAS, the Social Service Department (SSD) of the City of Muntinlupa and the Barangay Chairman of Cupang, conducted a survey on the victims of the fire to determine the homeowner basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance amount of Thirty Thousand Pesos (Php30,000.00) to

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 10th Sangguniang Panlungsod, to grant the total amount of Thirty Thousand Pesos (30,000.00) of Financial Assistance to Ms. Karen Barreto Kang affected by fire on February 28, 2024 located at No. 25 Cadiz St., Alabang Hills Village, Barangay Cupang, Muntinlupa City.

ENACTED FURTHER, that the Final Disaster Report dated February 28, 2024, of the Social Services Department (SSD) shall be charge to the 70% Quick Response Fund (QRF) from the Department of Disaster Resilience and Management (DDRM) with AIP Reference 1000-001-2-921-150-005-001 and Account Code of Other MOOE: 5-02-99-990, with CN: 2024-12 shall form part of this ordinance.
