AN ORDINANCE GRANTING THE TOTAL AMOUNT OF SEVEN MILLION ONE HUNDRED TWENTY THOUSAND PESOS (PHP7,120,000.00) OF FINANCIAL ASSISTANCE TO THE FAMILIES AFFECTED BY THE FIRE ON MARCH 17, 2024, LOCATED AT MARIATEGUI, PINAGPALA, BAUTISTA, CIPRIANO AND JOAQUIN, BARANGAY ALABANG, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on *March 17, 2024* **Four Hundred Eighty-Seven (487)** structures, housing **Nine Hundred Forty-Two (942) families**, were gutted by fire at **Mariategui, Pinagpala, Bautista, Cipriano And Joaquin, Barangay Alabang, Muntinlupa City**;

WHEREAS, in a final report rendered by the **Social Services Department** on **March 18, 2024**, and received by the **SP Secretariat Office** on **March 20, 2024** the following were noted as casualties of the said fire:

- 1. Four Hundred Eighty-Seven (487) structures;**
- 2. Two Hundred Fifty-One (251) families;**
- 3. Three Thousand Four Hundred Twelve (3,412) individuals;**
- 4. One Hundred Thirty-One (131) Children (0-5) years old;**

5. **Seventy-Two (72) Senior Citizens;**
6. **Eighteen (18) PWDs;**
7. **Seven (7) Lactating Mothers;**
8. **Five (5) Pregnant Women;**

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Alabang**, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of **Seven Million One Hundred Twenty Thousand Pesos (Php7,120,000.00)** financial assistance to be distributed as follows:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of **Seven Million One Hundred Twenty Thousand Pesos (Php7,120,000.00)** of Financial Assistance to the families affected by the fire on **March 17, 2024**, located at Mariategui, Pinagpala, Bautista, Cipriano And Joaquin, Barangay Alabang, Muntinlupa City.

ENACTED FURTHER, that the **Final Disaster Report** dated **January 15, 2024**, of the **Social Services Department (SSD)** shall be charge to the **70% Local Disaster Risk Reduction and Management Fund (LDRRMF)** with **AIP Reference** 1000-001-2-921-150-005-001 and **Account Code** of Other MOOE: 5-02-99-990, with **CN: 2024-13** shall form part of this ordinance.

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **18TH** day of **March 2024**, on its **87th Regular Session**.
