**WHEREAS**, on 23 October 2017, the Sangguniang Panlungsod adopted Ordinance 17-117 or "**An Ordinance Granting Allowance/Honorarium To Standing Committees, Councils, Boards And Other Special Committees**";

**WHEREAS**, the same ordinance provides, among others, allowance for each senior citizen barangay presidents in the amount of **Twelve Thousand Pesos (PhP12,000.00)** disbursed on a monthly basis and the financial aid/grant to senior association they hold;

**WHEREAS**, CSC-COA-DBM Joint Circular No. 1, s. 2017 provides for the Rules and Regulations Governing Contract of Service and Job Order Workers in the Government, the senior citizen barangay presidents fall within the ambit of the term contract of service;

**NOW THEREFORE, BE ORDAINED, AS IT IS HEREBY ORDAINED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlup in Session assembled that:

**SECTION 1. Short Title.** This ordinance shall be known as the Consultancy Allowance of Barangay Senior Citizen Presidents

**SECTION 2. Amendment.** Ordinance 17-117 in so far as the Senior/Elderly Consultancy Allowance is concerned shall be amended accordingly as follows:

**SECTION 3. Separability Clause** – If, for any reason or reasons, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 4. Repealing Clause.** All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

**SECTION 5. Publication.** This Ordinance shall be published pursuant to the requirements of the Local Government Code and shall be posted by the **Public Information Office (PIO)** in the Official Website of the City Government of Muntinlupa and in all available social media platforms.

**SECTION 6. Effectivity Clause** – This ordinance shall take effect after its completion of its publication in a newspapers of local circulation.
