AN ORDINANCE MODIFYING THE MONTHLY PAYOUT SCHEME IN THE DISTRIBUTION OF HANDOG KALINGA BENEFIT FOR SENIOR CITIZEN WITH AGE 90-100 YEARS TO EVERY TWO (2) MONTHS, AMENDING FOR THIS PURPOSE ORDINANCES NO. 17-109, 18-192 and 19-033

WHEREAS, the Sangguniang Panlungsod of Muntinlupa, pursuant to its mandate under the general welfare clause of Republic Act 7160 or the Local Government Code of 1991, enacted various legislations championing the cause of the elderly;

WHEREAS, on July 17, 2017 the An Sangguniang Panlungsod enacted Ordinance No. 17- 109 or An Ordinance Granting Additional Allowance To Senior Citizens With Age 90 To 99 And 100 Years Old And Above Who Are Residing In Muntinlupa City;

WHEREAS, Section 1, *Supra*, reads, This ordinance shall be known as an Ordinance Granting **MONTHLY** allowance to senior citizens with age 90 to 100 years old and above who are residing in the city of Muntinlupa;

WHEREAS, on August 20, the City Council enacted Ordinance NO. 18-192 also known as *An Ordinance Granting MONTHLY Allowance to Muntinlupa Resident Senior Citizens with age 90 to 99 and 100 years old and above Who Are Registered with the Handog Kalinga Program of the Office of the Senior Citizens Affairs (OSCA)*;

WHEREAS, Section 2 of Ordinance No. 18-192, reads, "A grant of **MONTHLY** allowance to the elderly/belonging to the following age bracket shall be distributed as follows:

90-99 years old	PhP1 ,000.00/Month
100years old and above	Php2,000.00/Month

WHEREAS, on **December 9, 2019**, Ordinance 19-033 or an Ordinance Granting Monthly allowance to Senior Citizens of Muntinlupa with age 80 to 100 years old and above was likewise enacted by the Sanggunian whereby Section 2 provides, "A grant of **MONTHLY** allowance shall be distributed to the elderly, who are registered voters of Muntinlupa or have been residing in the Muntinlupa for at least six months, according to the following age bracket:

- a. **80-89 years old - Five Hundred Pesos (PhP500.00)**
- b. **90-99 years old - One Thousand Pesos (PhP1,000.00)**
- c. **100 years old and above - Two Thousand Pesos (PhP2,000-00)"**

WHEREAS, in support of the **7K Agenda of the City Government**, particularly Katarungan, or "**pantay pantay na karapatan sa serbisyo, oportunidad at proteksyon sa ilalim ng batas**", and upon the recommendation of the implementing department, the monthly payment scheme of benefits implemented under the Handog Kalinga for a particular group of elderly is deemed necessary;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the **10th Sangguniang Panlungsod of Muntinlupa** in session as assembled that:

SECTION 1. Title. This ordinance shall be known as Modified Payment Scheme for aged 90 to 100 years old beneficiary of **Handog Kalinga Program**;

SECTION 2. Coverage. Provisions of this ordinance shall apply only to elderly Muntinlupa Citizens in the age bracket of 90-100 years old;

SECTION 3. Modified Payout. The monthly payout scheme in the distribution of Handog Kalinga benefit for senior citizen with age 90-100 years shall now be **every two (2) months**;

SECTION 4. Separability Clause – If, for any reason or reasons, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 5. Repealing Clause. All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 6. Publication. This Ordinance shall be published pursuant to the requirements of the Local Government Code and shall be posted by the Public Information Office (PIO) in the Official Website of the City Government of Muntinlupa and in all available social media platforms.






