WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, ***“Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”***;

WHEREAS, Section 455 (a) (vi) of Republic Act 7160, otherwise known as the Local Government Code, provides that, ***“the city mayor, as chief executive of the city government, shall exercise such powers and perform such duties and functions as provided by the Code and other laws and shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance”***;

WHEREAS, the Sangguniang Panlungsod enacted Ordinance No. 2022-035 establishing the **Womb to Work Program (WWP)** in the City of Muntinlupa which includes under the Stage 8 Employment Post-Development Stage, access to employers and on line Employment Portal for those those who are college graduates or certified technical/vocational skilled workers in Muntinlupa City;

WHEREAS, Section 10 of the Womb to Work Ordinance provides that the Muntinlupa People’s Coordinating Office (MCPO) as one of the implementing Local Government Offices of the Program may partner with Lingkod Muntinlupa Foundation to achieve the purpose of the ordinance;

WHEREAS, Lingkod Muntinlupa Foundation, Inc., is a non-stock, non-profit organization duly organized and existing under and by virtue of the laws of the Republic of the Philippines and is duly accredited by the Sangguniang Panlungsod through its adopted Resolution No. 2022-035;

WHEREAS, a Partnership Agreement is thereto forged between the City Government of Muntinlupa with Lingkod Muntinlupa Foundation (LMF) where the latter will share with the City, free of charge, a job portal software to be known as 1Munti Job Portal where employers and job applicants may interact for the purpose of filing in vacant positions;

WHEREAS, Lingkod Muntinlupa Foundation (LMF) shall, among others, manage the said job portal, provide the necessary hardware, conduct career orientation and coaching, appoint a Data Protection Officer and will be responsible for the physical, technical and organizational security of all personal and sensitive personal information contained therein;

WHEREAS, the CLO has no objection thereto, subject to the execution of a Data Sharing Agreement between the parties as well as the conduct of a threshold analysis on the data processing system to be implemented.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa,** to authorize the **City Mayor Rozzano Rufino B. Biazon,** to enter and sign the **Partnership Agreement (PA)** with **Lingkod Muntinlupa Foundation (LMF)** represented by **Atty. Camille R. Arcaraz,** for the implementation of **1Munti Job Portal.**
