A RESOLUTION AUTHORIZING HON. CITY MAYOR ROZZANO RUFINO B. BIAZON, ON BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD), REPRESENTED BY ITS DIRECTOR, RIO L. MAGPANTAY, MD, PHSAE, CESO III, FOR THE PROJECT CONSTRUCTION OF MEGA HEALTH CENTER UNDER THE HEALTH FACILITIES ENHANCEMENT PROGRAM (HFEP) AMOUNTING TO TWENTY MILLION PESOS (PHP20,000,000.00) TO BE FUNDED BY THE DOH

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that *"The State shall protect and promote the right to health of the people and instill health consciousness among them;"*

WHEREAS, Section 11, Article XIII, supra, states that *"The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled, women, and children. The State shall endeavor to provide free medical care to paupers;"*

WHEREAS, Section 6(c) of Republic Act No. 1123, known as the "Universal Health Care Act", states that *"The DOH and the local government units (LGUs) shall endeavor to provide a health care delivery system that will afford every Filipino a primary care provider that would act as the navigator, coordinator, and initial and continuing point of contact in the health care delivery system: Provided, That except in emergency or serious cases and when proximity is a concern, access to higher levels of care shall be coordinated by the primary care provider;"*

WHEREAS, Section 455(b)(1)(vi) of Republic Act 7160, otherwise known as the "Local Government Code of 1991", provides that, *"The City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance;"*

WHEREAS, Article 47(a), Rule IX of the Rules and Regulations Implementing the Local Government Code of 1991 provides that *“Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a LGU without prior authorization by the Sanggunian;”*

WHEREAS, the City Government of Muntinlupa (CGM), pursuant to the **7K Agenda of the Biazon Administration,** particularly **“Kalusugan”**, pursues the delivery of enhanced basic services which hinges on environment protection, improved health and sanitation and other programs strategically formulated for the constituency;

WHEREAS, under the MOA, the DOH-MMCHD transfer the amount of **Twenty Million Pesos (PhP20,000,000.00)** to the **CGM** to be used solely for the construction of the Muntinlupa Mega Health Center project under the Health Facilities Enhancement Program (HFEP) of the DOH and for other related purposes;

WHEREAS, further, the approved budget for the Health Facilities Enhancement Program (HFEP) under Republic Act No. 11639 or the “General Appropriations Act (GAA) of 2023” is apportioned for the construction, upgrading, or expansion of the government health care facilities such as DOH Hospitals, Local Government Unit (LGU) Hospitals, Rural Health Units (RHU), and Barangay Health Stations (BHS), which budget shall also include the procurement of medical equipment and motor vehicles for health care facilities to ensure that each facility can respond to the health needs of the people;

WHEREAS, the DOH-MMCH shall transfer and release the funds to the CGM after receipt of the documentary requirements corresponding to the scheme of **“Project Implemented by Contract”**;

WHEREAS, the City Legal Office has no objection to the said MOA, subject to the observance of pertinent budgeting, accounting and auditing rules and regulations;

NOW, THEREFORE, BE IT RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa to authorize **Hon. City Mayor Rozzano Rufino B. Biazon,** on behalf of the City Government of Muntinlupa, to enter into and sign the Memorandum of Agreement with the **Department of Health-Metro Manila Center for Health Development (DOH-MMCHD),** represented by its Director, Rio L. Magpantay, MD, PHSAE, CESO III, for the project construction of Mega Health Center under the Health Facilities Enhance Program (HFEP) amounting to Twenty Million Pesos (PhP20,000,000.00) to be funded by the DOH.

ADOPTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **4th** day of **March 2024,** on its **85th Regular Session.**






