WHEREAS, Section 455 (b)(1)9(vi) of the Local Government Code provides that, "the City Mayor shall exercise such powers and performs functions for efficient, a effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 16 of RA7160, the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod";

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, Role IX, Article 47(a) of the Rules and Regulations Implementing the Local Government Gode of 1991 provides that, "Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.";

WHEREAS, Section 35 of LGC of 1991, provides that, "Local government units may enter into joint ventures and such other cooperative arrangements with people's and nongovernmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.";

WHEREAS, Technical Education And Skills Development Authority (TESDA) Memorandum Circular No. 107 Series of 2021 also known as the Omnibus Guidelines on Technical Vocational Education and Training (TVET) Program Registration empowers TESDA to establish and maintain a system of accrediting, coordinating, integrating, monitoring and evaluating formal and non-formal NET programs provides for the Supervised Industry Learning (SIL) designed to complement the training gained in the institution with the intention of enhancing the knowledge and skills of a Learner through actual application of the core competencies in the workplace, as identified in the Training Regulations;

WHEREAS, the City Government of Muntinlupa (CGM), through its *Muntinlupa City Technical Institute (MCTI)*, supports the implementation of Republic Act No. 7796 or the TESDA Act of 1994, where local government units shall assume the responsibility for effectively providing community-based technical education and skills development opportunities;

WHEREAS, pursuant thereto, the CGM enters into a Memorandum of Agreement for SIL with Pilipinas Shell Foundation, Inc., represented by Sebastian C. Quiniones, Jr. Executive Director, a local enterprise where Learners for course/s on qualified interns of MCTI, may be trained;

WHEREAS, the MOA was submitted for review and the City Legal Office, interposed no objection as long as the relevant laws, guidelines and circulars on the matter are complied with;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the Honorable City Mayor Rozzano Rufino B. Biazon to enter and sign the Memorandum of Agreement (MOA) with Pilipinas Shell Foundation, Inc., represented by Sebastian C. Quiniones, Jr. Executive Director, on the implementation of the Technical and Vocational Scholarship Program for the Manila Golf and Country Club Foundation, Inc., caddies, and outsourced personnel and their dependents.
