WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Hotel Accommodation Inclusive of Full Board Meals, use of Function Hall & Transport Services for the Conduct of Lakbay Arai and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Million Eight Hundred Fifty Eight Thousand Six Hundred Forty Pesos (P2,858,640.00)(hereinafter called "the Contract Price").


