

THIS AGREEMENT made the _____ day of _____ 20____ between **CITY GOVERNMENT OF MUNTINLUPA** of the Philippines (hereinafter called "the Entity") of the one part and **GREAT LIFE HOTEL & LEISURE CORPORATION** with address at Silang Cavite (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Supply & Delivery of Meals w/accommodations & use of Function Room for the Conduct of Seminar Entitled "Values Orientation Workshop (V.O.W.) & GAD Enrichment Learning"** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Million Fifty Three Thousand Two Hundred Thirty Two Pesos (P3,053,232.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.



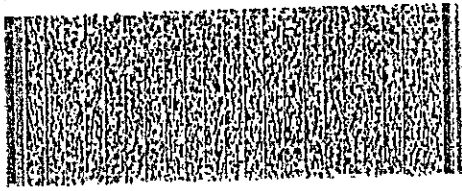
