AN ORDINANCE APPROVING THE 2024 ANNUAL BUDGET OF SANGGUNIANG KABATAAN (SK) OF BARANGAY BAYANAN, AMOUNTING TO FIVE MILLION SIX HUNDRED SEVENTY-TWO THOUSAND FIVE HUNDRED EIGHTY PESOS AND 05/100 (PHP5,672,580.05)

WHEREAS, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "the Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx, as one of the corporate powers of the city as provided in Rule IX of these rules, and shall: (i) "Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay.";

WHEREAS, on **March 21, 2024**, after the evaluation made by the City Budget Office, the **2024 Annual Budget of Sangguniang Kabataan (SK) of Barangay Bayanan** amounting to **Five Million Six Hundred Seventy-Two Thousand Five Hundred Eighty Pesos And 05/100 (Php5,672,580.05)** was endorsed to the Sanggunian for review dated **April 2, 2024**;

WHEREAS, the **SK Budget of Barangay Bayanan** as certified by the **Barangay Treasurer** for fiscal year 2024 is computed as follows:

Barangay Annual Budget FY 2024	- Php 89,500,000.00

WHEREAS, the City Budget Office recommended that the **FY 2024 SK Annual Budget of *Barangay Bayanan*** be ***declared operative in the entirety effective January 29, 2024*** subject to compliance with the following:

- a. ***Posting requirements under DBM-DILG-NYC JMC No. 1 Series of 2019;***
- b. ***Appropriations to be disbursed in accordance with Art 425 of the IRR, of Republic Act 7160 (Local Government Code); RA 10742 (Sanggunian Kabataan Reform Act of 2015) and its IRR; DBM-DILG JMC No. 1 s. 2019;***
- c. ***Compliance to the implementing guidelines and procedure pursuant to Section 4, of RA 11768 (amendments to RA 10742) and DBM Local Budget Circular No. 148 dated December 23, 2022;***
- d. ***Procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provisions of Republic Act 9184 (Government Procurement Reform Act) and prior clearances from pertinent agencies as maybe needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan;***

WHEREAS, the **SK Barangay Bayanan FY 2024 Budget** was found to have substantially complied with the laws and the same was executed pursuant to the prescribed power of the barangay;

NOW THEREFORE, BE IT ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to approved the **2024 Annual Budget of Sangguniang Kabataan (SK) Budget of Barangay Bayanan**, amounting to ***Five Million Six Hundred Seventy-Two Thousand Five Hundred Eighty Pesos And 05/100 (Php5,672,580.05)***.

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **22nd** day of **April 2024**, on its **92nd Regular Session**.
