AN ORDINANCE GRANTING THE TOTAL AMOUNT OF FORTY-THREE THOUSAND PESOS (PHP43,000.00) OF FINANCIAL ASSISTANCE TO TWO FAMILIES AFFECTED BY FIRE ON APRIL 20, 2024 LOCATED AT BLOCK 3 LOT 14 PAGSANJAN STREET, CAMELLA HOMES 4, BARANGAY POBLACION, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on *April 20, 2024* two (2) structures, housing two (2) families, were gutted by fire at **Block 3 Lot 14 Pagsanjan Street, Camella Homes 4, Barangay Poblacion, Muntinlupa City**;

WHEREAS, in a final report rendered by the **Social Services Department** on *April 22, 2024*, and received by the **SP Secretariat Office** on *April 23, 2024* the following were noted as casualties of the said fire:

1. **Two (2) structures;**
2. **Two (2) families;**
3. **Six (6) individuals;**
4. **Three (3) injured (Burn injuries)**

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Poblacion**, conducted a survey on the victims of the fire to determine the homeowner basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance amount of **Forty-Three Thousand Pesos (Php43,000.00)** financial assistance to be distributed as follows:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of **Forty-Three Thousand Pesos (Php43,000.00)** of Financial Assistance to two families affected by fire on **April 20, 2024** located at **Block 3 Lot 14 Pagsanjan Street, Camella Homes 4, Barangay Poblacion, Muntinlupa City.**

ORDAINED FURTHER, that the **Final Disaster Report** dated **April 22, 2024**, of the **Social Services Department (SSD)** shall be charged to the **70%** from the **Department of Disaster Resilience and Management (DDRM) Fund** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code of Other MOOE: 5-02-99-990**, with **CN: 2024-014** shall form part of this ordinance.
