WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on April 2, 2024 one (1) structure, housing one (1) family, were gutted by fire at Purok 13 Sitio Pag-Asa Precast, Barangay Alabang, Muntinlupa City;

WHEREAS, in a final report rendered by the Social Services Department on April 25, 2024, and received by the SP Secretariat Office on April 30, 2024 the following were noted as casualties of the said fire:

1. One (1) structure;
2. One (1) family;
3. Four (4) individuals;

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of **Ten Thousand Pesos (Php10,000.00)** of Financial Assistance to Ms. Roselyn Abrina Andrade affected by fire on **April 2, 2024** located at **Purok 13 Sitio Pag-Asa Precast, Barangay Alabang, Muntinlupa City**.

ENACTED FURTHER, that the **Final Disaster Report** dated **April 25, 2024**, of the **Social Services Department (SSD)** shall be charge to the **70%** from the **Department of Disaster Resilience and Management (DDRM) Fund** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code of Other MOOE: 5-02-99-990**, with **CN: 2024-015** shall form part of this ordinance.
