WHEREAS, on April 2, 2024 one (1) structure, housing one (1) family, were gutted by fire at Purok 13 Sitio Pag-Asa Precast, Barangay Alabang, Muntinlupa City;

WHEREAS, in a final report rendered by the Social Services Department on April 25, 2024, and received by the SP Secretariat Office on April 30, 2024 the following were noted as casualties of the said fire:

- 1. One (1) structure;
- One (1) family;
- Four (4) individuals;

WHEREAS, the Social Service Department (SSD) of the City of Muntinlupa and the Barangay Chairman of Alabang, conducted a survey on the victims of the fire to determine the homeowner basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance amount of Three Thousand Pesos (Php3,000.00) to Ms. Roselyn Abrina Andrade;

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 10<sup>th</sup> Sangguniang Panlungsod, to grant the total amount of Ten Thousand Pesos (Php10,000.00) of Financial Assistance to Ms.Roselyn Abrina Andrade affected by fire on April 2, 2024 located at Purok 13 Sitio Pag-Asa Precast, Barangay Alabang, Muntinlupa City.

ENACTED FURTHER, that the Final Disaster Report dated April 25, 2024, of the Social Services Department (SSD) shall be charge to the 70% from the Department of Disaster Resilience and Management (DDRM) Fund with AIP Reference 1000-001-2-921-150-005-001 and Account Code of Other MOOE: 5-02-99-990, with CN: 2024-015 shall form part of this ordinance.

ENACTED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 6<sup>th</sup> day of May 2024, on its 94<sup>th</sup> Regular Session.
