


AN ORDINANCE GRANTING THE TOTAL AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (PHP150,000.00) FOR ADDITIONAL FINANCIAL ASSISTANCE TO THE VICTIMS AFFECTED BY FIRE ON MARCH 17, 2024, LOCATED AT MARIATEGUI, PINAGPALA, BAUTISTA, CIPRIANO & JOAQUIN, BARANGAY ALABANG, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, the 10th Sangguniang Panlungsod enacted Ordinance No. 2024-166 or *An ordinance granting the total amount of Seven Million One Hundred Twenty Thousand Pesos (Php7,120,000.00) of Financial Assistance the families affected by the fire on March 17, 2024 at Mariategui, Pinagpala, Bautista, Cipriano and Joaquin, Barangay Alabang;*





WHEREAS, the allocation of **Seven Million One Hundred Twenty Thousand Pesos (Php7,120,000.00)** was for the more or less 900 families who were categorized to have suffered total damage on their properties;

WHEREAS, in a final report and received by the SP on May 2, 2024, additional fire casualties by reason of belated interview and assessment, discrepancies in documentations and appeal to be included in the official list of beneficiaries emerged as follows:

1. **Ten (10) structures;**
2. **Twenty (20) families;**

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Alabang**, conducted a survey on the victims of the fire to determine the homeowner basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance amount of **One Hundred Fifty Thousand Pesos (Php150,000.00)** to be distributed as follows:



NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of **One Hundred Fifty Thousand Pesos (Php150,000.00)** of additional Financial Assistance to the victims affected by Fire on **March 17, 2024**, located at **Mariategui, Pinagpala, Bautista, Cipriano & Joaquin, Barangay Alabang, Muntinlupa City**.

ENACTED FURTHER, that the Final Disaster Report dated **April 29, 2024**, of the **Social Services Department (SSD)** shall be charge to the 70% from the **Department of Disaster Resilience and Management (DDRM) Fund** with AIP Reference **1000-001-2-921-150-005-001** and Account Code of Other MOOE: **5-02-99-990**, with CN: **2024-013** shall form part of this ordinance.

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **6th day of May 2024**, on its **94th Regular Session**.




