AN ORDINANCE APPROVING THE BARANGAY BUDGET FOR FY 2024 OF BARANGAY PUTATAN AMOUNTING TO ONE HUNDRED TWENTY-TWO MILLION PESOS (PHP122,000,000.00)


WHEREAS, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "The Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx, as one of the corporate powers of the city as provided in Rule IX of these rules, and shall: (i) "Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay.";

WHEREAS, the City Budget Office after evaluation of Barangay Putatan's submitted budget found the same to have complied with rules, regulations, and appropriate memoranda on budget preparation, recommended its adoption;

WHEREAS, the proposed expenditure program follows the development directions of the *Barangay Development Plan* as approved by the Barangay Assembly and is fully consistent with the approved barangay *Annual Investment Program (AIP)* for the Fiscal Year 2024;

WHEREAS, the sources of fund of *Barangay Putatan* as certified by the City Treasurer are as follows:

WHEREAS, in compliance with the mandatory requirements of the law, the following have been provided: 49,892,833.33 50% PS 19,187,202.80 20% CDF 12,200,000.00 10% SK 6,100,000.00 **5% GAD** 6,100,000.00 5% BDRRMF 442,400.00 2% Discretionary Fund (DF) 959,360.14 1% BCPC 1,220,000.00 1% Anti-illegal Drugs Fund

WHEREAS, the City Budget Office recommended that the FY 2024 Annual Budget of Barangay Putatan be declared operative in the entirety effective January 1, 2024 subject to compliance with the:

"Procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provisions of Republic Act 9184 (Government Procurement Reform Act) and prior clearances from pertinent agencies as maybe needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan;

WHEREAS, the *Barangay Putatan* FY 2024 Budget was found to have substantially complied with the laws and the same was executed pursuant to the prescribed power of the barangay.

WHEREAS, Barangay Budget shall be available exclusively for the specific purposes of which have been appropriated and shall be spent solely for public purposes. Thus, no monies shall be paid out of Treasury except in pursuance of an Appropriation Ordinance or Law.

NOW THEREFORE, BE IT ENACTED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to approve the Barangay Budget for FY 2024 of Barangay Putatan, amounting to One Hundred Twenty-Two Million Pesos (PHP122,000,000.00).
